#### **Abstract**

This proposal seeks funding for an upgrade to room 143 in Angelle Hall. The envisioned upgrade would add an 86" flat-screen monitor, a power plate, wall-mounted speakers, and stackable chairs. These classroom changes would enrich our students' learning experience and provide a space for a more versatile teaching environment.

The technology in this grant would provide students studying Minor Brass Instruments, Guitar, Button Accordion, Piano, Opera Workshop, Cajun and Creole French Vocal Performance, Traditional Music Ensemble, and Commercial Music Ensemble. It would not only enhance student learning within classes, but it will directly impact 60-100 students in the major for whom a classroom like this is critical to their learning and professional preparation, and in turn, will impact students across campus by exposing them to different types of music taught on the UL campus.

### a. Purpose of grant and impact to the student body as a whole.

This grant aims to update Angelle Hall 143 by adding 86" flat-screen monitor, a power plate, wall-mounted speakers, and stackable chairs. This STEP application both describes the technology currently held and proposes the following acquisitions:

- 1. Currently, Angelle Hall 143 contains 20 wooden chairs with tablet arm desks and is not ergonomically designed for the diverse students who use the room. There are significant implications of using the existing chairs, including inflexible space layout, negatively impacting collaboration necessary for ensemble groups, and the chairs are not conducive to playing instruments as they negatively affect the correct sitting position and are uncomfortable during long practice sessions. The specified industry standard chairs promote good posture, enable better musicianship through alignment technique, eliminate obtrusive elements that may damage instruments, and are designed for music environments used by diverse user groups. If this grant is funded, the students can work in an interactive classroom, incorporating multimedia resources into the learning experience and creating a comfortable learning environment.
- 2. These upgrades will offer interactive visual aids, music videos, and digital presentations, enhancing students' engagement and comprehension. The multimedia additions to this room will help students study and practice and facilitate master classes and guest artists from around the country and world. The Traditional Music Program, Music Business Program, and Recording Arts Program often have remote guest artists/lectures/masterclasses with artists from all around the globe, and having this

ensemble-centered space appropriately set up to support those kinds of opportunities will enable us to dramatically increase the number and scope of guests that can interact with our students.

These updates will transform Angelle Hall 143 into an invaluable classroom and student workspace. It will enhance the quality of music education, aligning with our mission to provide exceptional learning opportunities for all our students.

**Impact on the student body:** It is one of the most heavily used classrooms, with students using it up to 50 hours a week.

#### b. Projected lifetime of enhancement.

The flat screen should last at least six years, at which point replacement is recommended. The chairs and other equipment should last longer than that projected timeframe.
