2. Abstract (250 words or less)

Presently, there are approximately 1,057 students registered with the Office of Disability Services as of December 2019. Funding of this STEP Proposal will assure that the UL Lafayette Office of Disability Services will be able to provide the necessary equipment to allow for online testing for students with disability accommodations. This proposal meets requirements of both access and support initiatives.

3. Description

A. Purpose of grant and impact to the student body as a whole

The Americans with Disabilities Act (ADA) of 1990 mandated that all university courses, lab, activities, buildings, etc. be accessible to students with disabilities. Students with disabilities comprise approximately 5% of the total number of students in the university. In order to impact the student body as a whole, students with disabilities must have adaptive equipment to assist in testing situations and academic needs.

The number of students registered with ODS has **increased by 80% in the last five years**. A big part of what we do at ODS is administer exams with extended testing time and in an environment with reduced distractions. Approximately 95% of students registered with ODS are approved for extended testing time and testing in a reduced distraction environment. More and more faculty are administering exams via the internet (Moodle, Connect, Top Hat etc.) therefore the ODS testing center must provide the equipment needed for students to take online exams. This presents a problem during final exam week (and other high volume testing times) during each semester.

Final Exam Week:

During the Fall 2018 semester, ODS moved its base of operations to the Student Union ballroom during final exam week. Due to the increased number of students requiring extended testing time and other testing accommodations, ODS was no longer able to provide final exam testing in Agnes Edwards Hall. Moving the office to the Student Union ballroom afforded us the opportunity to have most of our students in one central location which freed up staff to provide proctoring and effective management over the operation. As the student union currently has no STEP lab, ODS set up a make-shift computer lab in the Teche room of the union to provide testing for online exams. We are currently transporting computers from our ODS STEP lab to the Teche room in the union during final exam week. Having the necessary laptops needed to provide these exams will mean we can easily set up the Teche room for moodle (and other online) exams. We can also set up laptops along the rear wall of the ballroom to allow students taking online exams to sit with the general population, which helps our staff with management of the operation.
